

Terms and Conditions - Crown Perth Red Packet Sets

1. **Promotion:** Crown Perth Red Packet Set
2. **Promoter:** Burswood Nominees Limited ABN 24 078 250 307 as trustee for The Burswood Property Trust ABN 35 491 489 282 trading as Crown Perth, Great Eastern Highway Burswood, Western Australia 6100.
3. **Offer Period:** The Offer will occur between 10am on Monday 10 January 2022 and 11.59pm on Tuesday 15 February 2022 (with each day being an **Offer Day** during the **Offer Period**). All times recorded throughout these Terms and Conditions are in Australian Western Standard Time.
4. **Offer:** Patrons over 18 years old and who have not been excluded from the property of the Promoter, Crown Melbourne or Crown Sydney for any reason, may redeem or purchase a Red Packet Set, as follows:
 - Redeem with 300 Crown Rewards points for Crown Rewards members; or
 - Payment of \$8 for Crown Rewards members; or
 - Payment of \$20 for Non- Crown Rewards members.

Each Red Packet Set contains twenty-four (24) individual red packets.

 - Non-Crown Rewards members –
