Application for Self Exclusion from Crown Casinos

I _____ make this Self Exclusion Application (**Application**) to be prohibited from entering or remaining in the casino operated by Crown Melbourne Limited ('**Crown Melbourne**') and the casino operated by Burswood Nominees Limited ('**Crown Perth**') (each a '**Crown Casino**'). In making this Application, I acknowledge and agree to the following terms and conditions:

1. (**Voluntary Process**) I have made this Application voluntarily and of my own free will and Crown Casino has recommended that, prior to signing this document, I should discuss this matter with an independent legal advisor;
2. (**Disclosure within Crown Group**) I agree that my personal information will be disclosed to each Crown Casino and to Betfair Pty Ltd to facilitate my self exclusion and to cease any marketing being sent to me by a Crown Casino or Betfair Pty Ltd;
3. (**Operation of Self Exclusion Order and Agreement**) If this Application is approved:
 - a) **I will be issued an Exclusion Order (Self Exclusion) for Crown Melbourne (Self Exclusion Order), and be required to enter into a Self Exclusion Agreement for Crown Perth (Self Exclusion Agreement), which will legally prohibit me from entering or remaining in those Crown Casinos;**
 - b) I will do all things reasonably necessary to facilitate this Application; the Self Exclusion Order; the Self Exclusion Agreement and related processes, as directed by any Crown Casino;
 - c) I am committing an offence and proceedings may be issued against me if I enter or remain in any Crown Casino, including for Crown Melbourne, an offence against section 77 of the *Casino Control Act 1991* (Vic) and under which I may be liable for a fine of 20 penalty units;
 - d) I am fully aware that, unless my self exclusion is revoked, I am a person who is self excluded;
 - e) It is my personal responsibility (and not that of any Crown Casino) and I undertake not to enter or gamble within all gaming areas of any Crown Casino; and
 - f) I will seek the assistance of a qualified gambling counsellor and comply with recommendations of the counsellor;
4. (**Regulatory Notification**) Crown is required to forward a copy of this Application and the Self Exclusion Order to the Victorian Commission for Gambling and Liquor Regulation ('**VCGLR**'). The VCGLR and other regulatory agencies, including the Gaming and Wagering Commission of Western Australia, may direct any Crown Casino to produce all documents relating to this Application;
5. (**Release and Indemnity**) I agree to release and indemnify each Crown Casino and their related entities, together with their officers, employees, agents and contractors from any liability, including any losses that arise in connection with this Application; the Self Exclusion Order; or Self Exclusion Agreement;
6. (**Personal and Sensitive Information**) I consent to photographs being taken of me, together with my personal and sensitive information, including a valid form of identification, being collected, used and disclosed for the purposes of processing this Application and enforcing my Self Exclusion Order, Self Exclusion Agreement or other related purposes. I agree to provide any further evidence of my identity, as may be reasonably requested by any Crown Casino; and
7. **A Self Exclusion Order and Self Exclusion Agreement issued pursuant to this Application takes immediate effect. I agree to follow the process required by Crown Casino to apply for the Self Exclusion Order and Self Exclusion Agreement to be revoked.**
