	11pm Jackpot winners:
	When a Jackpot prize winner has been identified from 11pm, the Winning Machine will display a winner notification message and lock up. A Gaming Machine attendant will attend to the winner and assist with instructions on how the winner will participate in a promotional game to determine the prize they have won.
Promotional Game (11pm Jackpot Prize Winners)	Once the two (2) 11pm Jackpot winners have been identified they will participate in a promotional game of 'Aussie Outdoor Snap' to determine their prize.
