Prize Draw Day (Friday 12 December): To participate all eligible Entrants must visit a Voucher Issuance Kiosk (VIK) between 7pm and 9.55pm to print their entries and place them in the prize draw barrel located at the promotional stage (main Casino Stage), in the Riverside Room or in the Pearl Room before a Prize Draw to be eligible for the Prize Draw(s).
