Instructions for submitting an email Application for Self Exclusion from Crown Casinos

Conditions of and email Application for Self Exclusion

The terms and conditions of an *Application for Self Exclusion from Crown Casinos* (**Application**) are set out at paragraphs 1-7 of the Application (**Conditions**). Prior to making an Application, it is important that you understand the Conditions.

If you require clarification or explanation of the Conditions, please contact the Responsible Gaming Team at Crown Perth on 1800 801 098 or seek independent legal advice. By submitting an Application to Burswood Nominees Limited (trading as Crown Perth), you acknowledge and agree that you have read the Conditions and agree to abide by them.

Making an email Application

To make an Application, you must submit the following documents in accordance with these instructions:

- a copy of your Application which has been signed by you and your signature witnessed by one of the authorised professionals in the list attached to this letter; and
- a colour copy of your current photo identification which has been certified as being a true copy of the original identification by one of the authorised professions in the list attached to this letter in accordance with the example below; and
- a recent high resolution photograph of you.

Certifying your photo identification

The copy of your photo identification must be certified as a true copy by having an authorised professional write these words on the copy and signing the copy:

"I certify that this is a true and accurate copy of the identification of [your name] sighted by me on [insert date]."

Submitting your email Application

Your completed Application, certified identification and photograph can be submitted via email to rgc@crownperth.com.au Alternatively if you would prefer to return your application via mail please contact the Responsible Gaming Team on 1800 801 098 for instructions. Please include a phone number on which we can contact you with your Application.

Once we receive your Application we will contact you to:

- · Verify your identity;
- Discuss the reasons for your Application;
- Confirm your nominated period of exclusion;
- Check your understanding of the Conditions of the Application; and
- To offer support.

We will then finalise your Application and send you copies of your *Application for Self Exclusion* together with your *Self Exclusion Agreement for Crown Perth, your Exclusion Order for Crown Melbourne and your Exclusion Order for Crown Sydney* which will specify the length of time of your exclusion.

Your Self Exclusion Agreement and Self Exclusion Orders issued pursuant to your Application, once finalised, takes immediate effect and will be maintained until it is revoked in writing by Crown.

Revoking (ending) an Application for Self Exclusion

An application to revoke a Self Exclusion may be made after the minimum nominated period stated in the Self Exclusion Agreement or Orders has passed by submitting an Application for Revocation of Self Exclusion. Applicants are required to successfully complete the revocation process before being permitted to return to the Casino.
