Entrants who do not visit a VIK to register their participation during this period will not be considered an eligible entrant for the promotion.</p> <p>For avoidance of doubt, if entrants register by 12pm, they will be eligible for the 1pm, 2pm and 3pm prize draws. However, entrants will have to visit a VIK again from 4pm or they will not be eligible for the 5pm, 6pm and 7pm prize draws.</p> <p>There will be no entry forms printed.
