In the event of a VIK malfunction the Promoter reserves the right to pause the Promotion until the malfunction is rectified and the entry mechanism detailed above shall resume.</p> <p>In the event of a severe technical malfunction, the Promoter reserves the right to pause or delay the Promotion into another time or another date which shall be announced within the Promoter's venue.</p> <p>Crown Rewards points will be 'earned' at the time they are posted to the Eligible Entrant's Crown Rewards points balance in accordance with the Crown Rewards Terms and Conditions, see crownperth.com.au/crown-rewards.
