1 Tournament Details

- 1.1 Date:
Commencement date: March 24, 2026
Completion date: April 11, 2026
- 1.2 Buy-in: See Attachment/s
- 1.3 Admin Fee/Entry Fee (inclusive of GST): See Attachment/s.
- 1.4 Location: Crown Perth Casino
- 1.5 Tournaments will be conducted in accordance with the Attachment/s.
- 1.6 The scheduled commencement time for each Tournament is approximate, and the Tournament Director reserves the right to alter the start time of a Tournament.
- 1.7 This Tournament may be cancelled by Crown at any time prior to commencement of the Tournament date and time for any reason including due to unforeseen circumstances beyond Crown's control. If the Tournament is cancelled by Crown, the entry fees paid by Entrants will be refunded.
- 1.8 The Gaming and Wagering Commission will be notified prior to any change to the schedule.
- 1.9 An "Entrant" or "Entrants" under these Terms and Conditions means those Entrants who are eligible to enter the Tournaments in accordance with the Conditions of Entry, and in compliance with condition 2.3, excluding for the avoidance of doubt any Ineligible Player as defined in condition 2.3.
- 1.10 Number of Entrants: All Tournaments will have minimum of 2 and a maximum of 99 seated Entrants unless otherwise stated.
- (a) The number of Entrants may also include "late entries". "Late entries" are Entrants permitted to enter a Tournament/satellite with a full starting bank of chips, within a predetermined period after the Tournament starts.
- (b) They firstly are allocated to any empty seats, then followed by a random draw either as other Entrants are eliminated or when an additional table is added subsequent to the Tournament commencement.
- 1.11 Tournaments will be conducted in accordance with the Crown PlaySafe Code of conduct, including Play Period policies.
- If an entrant's time gambling reaches the following limits, they will be required to take the following breaks:
- (a) continuously for three (3) or more hours, will require a mandatory fifteen (15) minute break;
- (b) twelve (12) hours in a twenty-four (24) hour period, we require a mandatory twenty-four (24) hour break;
- (c) and forty-eight (48) hours in any seven (7) day period, will require a mandatory seventy-two (72) hour or three (3) day break.

2 Conditions of Entry

- 2.1 Participation in any of the Tournaments listed in the Attachment/s constitutes an acceptance of these Terms and Conditions, Crown Perth's Conditions of Entry and the Approved Rules of the Authorised Game of Poker under Section 22 of the Casino Control Act 1984 (WA) (**Rules**).

- 2.2 In the event of any inconsistency between these Terms and Conditions and the Rules, the Rules will prevail.
- 2.3 Only persons entitled to enter and remain in the Crown Perth casino and gamble are eligible to enter. Ineligible Players, means:
- (a) any person who may not enter or remain in the Crown Perth Casino arising out of the operation of or as contemplated by, section 26 of the Casino Control Act 1984, for the period that person may not enter the Crown Perth Casino arising out of the operation of, the section or the Burswood Casino Directions;
 - (b) any person who has notified the Casino Operator that they wish to be excluded from Crown Perth Casino, for the period the person is excluded from Burswood Casino following that notification;
 - (c) any person who, following a request by a third party, the Casino Operator has determined should be excluded from Crown Perth Casino, for the period the person is excluded from Crown Perth Casino following that determination;
 - (d) any person who may not enter any other Casino in Australia owned or operated by the same owners of Crown Perth Casino (Other Casino), for the period that person may not enter any Other Casino; and
 - (e) any person who has nominated the Crown Perth Casino as their Player Activity Statement Address and who has not been provided with a Player Activity Statement for any month in which they were an Active Player within 7 days following the end of that month, for the period until they are provided with a Player Activity Statement for that month.
- 2.4 The Management of Crown Perth Casino reserves the right to refuse any application for entry into in any of the Tournaments listed in the Attachment/s and the participation of any nominated substitute.
- 2.5 Applications for entry into any of the Tournaments listed in the Attachment/s will be recorded by Crown Perth and may be made as follows:
- (a) Where available, by completing an on-line registration form (non-metropolitan area only) or
 - (b) In advance of, or during the conduct of the Tournament by registering in person at the Poker registration desk in the Poker Room or the Main Cage.
- 2.6 Prior to being eligible to participate in any of the Tournaments detailed in the Attachment/s, each person must be a valid Crown Rewards Member.
- 2.7 All Entrants may view the Tournament Terms and Conditions prior to registering for the Tournament and all Entrants must abide by these, or risk disqualification. Copies of the Terms and Conditions will be made available throughout the duration of the registration and the Tournament in the Poker Room or upon request.

- 2.8 Each person may be requested to provide their Crown Rewards Card or quote their Crown Membership Number and provide valid photo ID:
- (a) Each time they enter a Tournament; or
 - (b) If requested, when collecting a prize; or
 - (c) If a Tournament lasts for more than one day, at the end of a day's play and/or at the commencement of play on the next day.
- 2.9 Entrants' personal information collected will be handled in accordance with Crown's Privacy Policy (available on request or on Crown's website) unless otherwise provided for in these Terms and Conditions unless a request for anonymity is received from an Entrant and acknowledged by the Tournament Director.
- 2.10 Crown Perth Casino reserves the right and licence to use Entrants' names, suburbs, photographs, images and likenesses for the purpose of promoting and advertising Crown Rewards and/or Crown Perth. By entering the Tournament, Entrant's consent to Crown Perth using this information for these purposes.

3 Transfers/Refunds/Seats

- 3.1 The buy-in and entry/admin fee, if any, may be refunded if a Tournament does not proceed or, where prior to the commencement of a particular Tournament, it is determined in accordance with these Terms and Conditions that an Entrant is ineligible to enter that Tournament.
- 3.2 The buy-in and entry/admin fee, if any, may **not** be refunded to an Entrant who is:
- (a) Disqualified from a particular Tournament; or
 - (b) Removed from the casino premises and/or is excluded from re-entering for a period of time, whereby that Entrant's remaining Tournament chips will be taken out of play.
- 3.3 If an Entrant withdraws from a Tournament more than six (6) days prior to the scheduled Tournament date, the buy-in only is refundable, or may be transferred to another person in accordance with clause 3.4.
- 3.4 At the discretion of the Tournament Director, an Entrant may transfer their entry to another person, provided that:
- (a) the other person is entitled to enter the Tournament in accordance with these Terms and Conditions;
 - (b) the other person has not already entered the Tournament; and
 - (c) the transfer is requested no less than 24 hours prior to the Tournament start time.

4 Tournament Format

All Tournaments will consist of one or more Rounds/Sessions and/or a Final and will be played on one or more tables; the number of tables being determined by the number of entries received for a particular Tournament. The specific Tournament formats will be in accordance with the Attachment/s.

5 Shot Clock Tournament

A Shot Clock Tournament is whereby Entrants are required to act on their hand within a preset time period which shall be documented in the Attachment/s.

Where a Tournament is using a Shot Clock format, point 9, Time to Act, will not be applicable.

- (a) For Rounds/Sessions other than the final table, Entrants will have a 10 second period to act on their hand and for the final table Entrants will have 30 seconds to act on their hand.
- (b) If an Entrant does not act on their hand within the preset time period;
 - (i.) Where a wager has been made, their hand will be dead at the completion of the preset time period.
 - (ii.) Where no wager has been made, they will automatically check at the completion of the preset time period.

Entrants may be offered Time Banks at the start of a Shot Clock Tournament. Time Banks are tokens that can be used by players to extend the time to act on their hand during Shot Clock Tournaments.

Each Time Bank can be used throughout the Tournament and shall be:

- (a) equal to the preset time period;
- (b) be used only once;
- (c) collected by the Dealer once used.

6 Table and Seat Allocation

The names of all Entrants for a particular Tournament will be drawn by ballot or randomly generated by computer to determine both the Entrant's table number and seating position.

- (a) The number of Entrants allocated to any one table will be at the discretion of the Tournament Director.
- (b) On a particular table, position 1 is located to the immediate left of the Dealer, with position numbers ascending in a clockwise order.
- (c) A high card draw for the Dealer button will be held at the beginning of each Tournament on one table and be applicable to all tables in the Tournament.
- (d) Seating assignments may be altered to ensure that Entrants, where known by Crown, are connected by family or association, play at different tables or are separated on the final table.
- (e) Seating assignments may be altered to accommodate players with special needs.
- (f) The Tournament Director and/or their deputies may remove an Entrant/s chips out of play if they have not taken their seat by the allotted time.
- (g) Players will not be permitted to play on a Tournament poker table and a cash poker table at the same time without prior approval from the Tournament Director, Table Games Manager or above.

7 Wagers

- (a) All wagers will be made with Tournament chips, and all Tournament chips are the property of the Casino Operator.

- (b) Entrants in a particular Tournament will each be allocated the same amount of Tournament chips and will be advised of the actual amount of chips prior to the commencement of the Tournament. A starting bank of chips will be placed on the table in front of each designated playing area.
- (c) An Entrant's bank of chips must remain on the table in full view of all participants, with the highest denomination chip the most prominent, until each Session is completed, and the winner(s) is determined.
- (d) Players are entitled to a reasonable estimation of an opponent's chip count; thus, chips should be kept in countable stacks. Players must always keep higher denomination chips visible and identifiable.
- (e) A bank of chips will not be augmented or removed from the table by an Entrant during the conduct of Tournament play, unless in the form of a re-buy or add-on.
- (f) Where an Entrant is re-seated by the Tournament Director, they must transfer their bank of chips so that the chips remain in clear view of the Dealer and the Tournament Entrants. Failure to do so may result in the chips being forfeited.

8 Re-entries, Add-ons and Alternates

- (a) Where a Tournament allows re-entries, Entrants who have been eliminated from a Tournament may re-enter the event by paying the buy-in and entry/admin fee again. The number of re-entries and the duration of time Entrants are permitted to re-enter will be determined by the Tournament Director and announced prior to the commencement of that particular Tournament.
- (b) Where the Tournament allows add-ons, all Entrants in that particular Tournament may purchase an additional bank(s) of chips at the end of a predetermined period of time. Players must place their add-on monies (cash/cash chips) in front of their stacks to indicate their intentions to add-on.
- (c) Where the Tournament allows alternates (Entrants that exceed the maximum number of seated players), those Entrants will be seated once players are eliminated.
- (d) Late entries, alternates or re-entries are Entrants permitted to enter a Tournament with a full starting bank of chips, within a predetermined period after the Tournament starts. They are allocated by a random draw either as Entrants are eliminated or when an additional table is added subsequent to the Tournament commencement.

9 Time to Act

The specific amount of Time to Act in a Tournament will be as follows:

- (a) Entrants may request to 'put the clock' on another Entrant.
- (b) Subject to the request being reasonable,
 - (i.) The Tournament Director will call "time" and the Entrant in question will have one minute to act;
 - (ii.) If action has not been taken by the time of 50 sec has elapsed, there will be a 10-second countdown;
 - (iii.) If an Entrant has not acted on their hand by the time the countdown has elapsed, the hand will be dead and all wagers made by that Entrant will remain in the pot(s).

- (c) The Tournament Director may also call “time” on an Entrant if it is deemed that the Entrant is slow to act on their hand deliberately and or continually.
- (d) If the Tournament Director determines that an Entrant is being slow to act on more than one occasion in the same Satellite, that Entrant may be given a maximum of 10 seconds to act for all subsequent rounds of play.

10 Betting Limits

10.1 The betting limits, together with the timing of increases in blinds and/or antes, will be determined by Crown and set out in the Attachment/s.

It is the caller’s responsibility to determine the correct amount of an opponent’s bet before calling, regardless of what is stated by the Dealer or players. If a caller requests a count but receives incorrect information from the Dealer or players, then places that amount in the pot, the caller is assumed to accept the full correct action & is subject to the correct wager or all-in amount.

- (a) In No Limit games, a single oversize chip without an announcement or indication of intent to raise will:
 - (i.) In the first betting Round, constitute a call; and
 - (ii.) In subsequent betting Rounds, if it is the first bet of that Round, it will constitute the size of the oversize chip bet, or the maximum bet permitted within the betting limits. If it is not the first bet of the Round it will constitute a call.
- (b) In all games, if an Entrant makes a raise of 50% or more of the previous bet without an announcement or indication of intent, they will be required to make the raise up to the minimum raise permitted. In all games, unless going ‘all in’, if an Entrant makes a raise of less than 50% of the previous bet or raise, without an announcement or indication of intent, it will be taken as a call.
- (c) Where an Entrant bets unannounced with two chips of the **same** denomination totalling more than the amount to call and less than the minimum amount to raise (and one chip value is less than the previous bet), it is only a call this instance, clause (e) does not apply.
- (d) In all games, if an Entrant makes a bet of less than the amount required to call, they will be required to make up the difference or fold and surrender the initial bet, which then forms part of the pot.
- (e) In No Limit games, if an Entrant states the intent to raise and bets with an oversize chip, the raise will be the maximum amount allowable up to the size of that chip.
- (f) In No Limit games, when raising, an Entrant must either bet the amount of the raise in one ‘clean’ motion or state the raise amount. By stating the intent to raise, an Entrant protects his/her right to raise, but the raise must still be completed as per the previous sentence guidelines.

10.2 Verbal declarations in turn are binding. Verbal declarations or action out of turn may also be binding.

- (a) If an Entrant bets, raises or calls out of turn, the action stands.
- (b) If an Entrant who should have acted prior to the out of turn Entrant chooses to bet more than the out of turn bet, the Entrant who acted out of turn can either make up the difference to call, or take back his bet and fold, or re-raise.

- (c) An Entrant who checks out of turn forfeits all rights to bet or raise.
- 10.3 If a player does not have a sufficient table stake to meet a wager but wishes to stay in the game, they shall wager the remaining amount of their table stake which shall be known as tapping out. A player tapping out shall remain in the round of play as an active player until the showdown, taking no further part in any subsequent betting round.
- 10.4 Should the player tapping out have the highest-ranking hand at the showdown they will win only the pot they are eligible for.

11 General

- 11.1 Dealers will deal 'round for round' generally when the number of Entrants remaining exceeds places paid by two and 'hand for hand' when the number of Entrants remaining exceeds places paid by one.
- 11.2 All cards will be turned face-up once an Entrant is 'all-in' and all action is complete.
- 11.3 In the event of a split pot, where there is an odd chip, the odd chip will be broken down to the lowest denomination chip in play on the table at that time. If, after the odd chip has been broken down, an amount remains that cannot be equally divided, that remaining amount will go to the nearest active hand to the left of the button.
- 11.4 A hand may be ruled retrievable by the Tournament Director.
- 11.5 When it is time to "colour-up" chips (remove the smallest denomination chips on the table), each player's chips will be counted by the Dealer and exchanged for the larger denomination chips. Chips will be rounded up (e.g., \$350 worth of \$25 chips will be exchanged for 4x\$100 chips) or a "race off" for any odd chips will be completed at the discretion of the Tournament Director.

When conducting a 'race off', the Dealer will:

- a) Deal one card for each odd chip to be raced off starting from seat 1 in a clockwise direction
- b) Award chips to the players with the highest card value (If more than one player has the same value card, the order of suits will apply (Hearts, Clubs, Diamonds and Spades))

An Entrant cannot be "raced out" of a Satellite. If an Entrant loses the "race off" and has no chips remaining, they will be given one chip of the smallest denomination in play, so that they can participate in the next round of play.

- 11.6 Subject to the Rules, the unobtrusive use of audio headphones, iPod or other similar electronic devices will be permitted up until the first table where prize money is paid.
- 11.7 Unless being re-seated in accordance with clause 6.3, an Entrant must be at the table by the time the Dealer has completed the initial deal, or their hand is dead.
- 11.8 There will be no foreign chips allowed on the table except for a maximum of one card protector per Entrant. The card protector must be smaller than the deck of cards in use.
- 11.9 When new betting limits are announced, the limits apply from the next round of play. A round of play begins when the Dealer gathers the cards to shuffle. When time has elapsed in a level and a new level is announced, the new level applies to the next round of play.
- 11.10 When only two Entrants remain in a Tournament, the Dealer button will be on the small blind and is first to act before the "flop" and last to act after the flop. The first card of a

round of play is dealt to the player who does not have the Dealer button. The button will be adjusted so that no Entrant will pay the big blind twice in succession.

12 Elimination

- 12.1 Entrants in a particular Tournament will be eliminated from that Tournament when they have lost their bank of Tournament chips and no further re-entries or add-ons are allowed.
- 12.2 As Entrants are eliminated from the Tournament, the number of tables may be reduced at the discretion of the Tournament Director.
- 12.3 To maintain balanced tables throughout the duration of the Tournament, Entrants may be re-seated at the discretion of the Tournament Director. Unless deemed otherwise by the Tournament Director, the following procedure will be applied:
 - (a) A difference of two Entrants between Tournament tables is acceptable. During the final stages of a particular Tournament a difference of two Entrants will be balanced as soon as is practicable.
 - (b) Tables will be balanced by moving an Entrant from the left of the big blind position from the table to be reduced to the table that requires balancing.
 - (c) Entrants must promptly move to the table as requested or risk incurring a penalty as described in 9.2
- 12.4 Where an Entrant is re-seated, they will assume all rights and responsibilities of their new position. An Entrant moving to a new table is eligible to be dealt a hand in any position, except if they are seated in between the Dealer button and the small blind.
- 12.5 In the event of more than one Entrant being eliminated from a Tournament during the same round of play on the same table, places will be allocated relative to the size of the eliminated Entrants' respective Tournament chip banks prior to the commencement of that particular round of play.
- 12.6 In the event of two Entrants being eliminated from two separate tables on a corresponding round of play; those Entrants will be equal in placing regardless of their Tournament chip bank at the commencement of that particular round of play.
- 12.7 Once an Entrant has lost their bank of chips and exhausted all opportunities to re-buy or add-on (as applicable) and is subsequently eliminated from a Tournament, they will not be permitted to re-enter that particular Tournament unless otherwise stated.

13 Tournament Winner

The winner(s) for a Tournament will be the last Entrant(s) remaining in that particular Tournament after all other Entrants have been eliminated.

14 Prize Pool

- 14.1 Crown Perth may add value to a prize pool in the form of cash, goods or services.
- 14.2 A Tournament prize pool will consist of all buy-ins, re-entries and add-ons less any entry/admin fee.
- 14.3 Entrants in a particular Tournament where possible will be advised of the actual prize pool break up prior to or as soon as practical after the commencement of the Tournament.

15 Conduct of Play

15.1 The Tournament Director may penalise any Entrant who fails to comply with these Terms and Conditions or whose behaviour is assessed as being detrimental to the integrity or the proper conduct of the Tournament, and is against Crown Perth's Conditions of Entry and/or Code of Conduct, including, but not limited to the following examples:

- (a) Abuse of casino employees, either verbally or physically.
- (b) Abuse of other Entrants, either verbally or physically.
- (c) An Entrant showing their cards or verbally advising the content of their hand to another Entrant(s) when the betting round is not complete.
- (d) Exposing hole card(s) with action pending.
- (e) Causing card(s) to go off the table.
- (f) Advising another Entrant how to play a hand.
- (g) Deliberately miscalling a hand.
- (h) Collusion.
- (i) Intentionally avoiding payment of a blind when moving from a broken table.
- (j) Discussion of the particular hand in play prior to action being complete by any Entrant on the table whether in the round of play or not.
- (k) One Entrant to a hand rule – no seeking advice from other competitors or bystanders.
- (l) Acting out of turn.
- (m) Concealing hole cards or chips from another Entrant(s);
- (n) Being, or assessed by Crown as being, intoxicated; and
- (o) During a Tournament, displaying a sponsor's logo in circumstances where that display has not been agreed to by the Tournament Director prior to the commencement of the Tournament.

15.2 Penalties imposed may be as follows:

- (a) Exclusion from the table for one or more rounds of play (blinds, antes and/or forced bets to be forfeited).
- (b) Time penalties of 5, 10, 20 or 40 minutes away from the table may also be used (blinds, antes and/or forced bets to be forfeited).
- (c) Disqualification from the Tournament.

15.3 The Tournament Director reserves the right to read any unexposed hands to determine whether collusion has occurred.

15.4 If, at the commencement of a Tournament, an Entrant does not take their allotted seat at the specified times as nominated by the Tournament Director, and is not disqualified:

- (a) All antes, blinds and forced bets will be deducted from the set amount of an Entrant's Tournament chips for each Round of betting until they take their allotted seat. The Entrant's position at the table will still be dealt in and retain all rights as if they were present at the table; and
- (b) In accordance with these Terms and Conditions, the Entrant may nominate, in person, a substitute to take their allotted seat during any Tournament.

- 15.5 During a particular Tournament, any Entrant who is absent from play will have all antes, blinds and forced bets deducted from the set amount of their Tournament chips for each Round of betting until they return. The Entrant's position at the table will still be dealt in during the absence and retain all rights as if they were present at the table.
- 15.6 Any Entrant who retires during play may:
- (a) Nominate a substitute in accordance with these Terms and Conditions; or
 - (b) From the time of retirement, continue to have all antes, blinds and forced bets deducted from the value of their chip stack. The Entrant will remain eligible to progress to the next Round/Session or Final as the case may be and remain eligible to be awarded any applicable prize in accordance with these Terms and Conditions.
- 15.7 Where a substitute is nominated, entry into the Tournament will be transferred to the substitute and the substitute will act on behalf of the Entrant, commencing or continuing play in the Entrant's stead and using any applicable bank of Tournament chips allocated to or accumulated by the Entrant.
- 15.8 The Tournament will be conducted by the Tournament Director and/or their deputies in accordance with these Terms and Conditions, Conditions of Entry and the Rules as applicable. A deputy of the Tournament Director will be a Dealer (or above) who has been appointed as a Tournament Supervisor for this particular Tournament.

16 Discrepancies and Rulings

- 16.1 A player is responsible in reporting any errors, discrepancies or violations that promote an unfair game.
- 16.2 The player is to notify the Tournament Directors and/or the Dealer of any irregularities when it occurs. Any delay in reporting a discrepancy may affect the ruling once a new round of play has commenced and the results of the previous round of play may stand.
- 16.3 The Tournament will be conducted by the Tournament Director and/or their deputies in accordance with these Terms and Conditions, Crown Perth Conditions of Entry and the Rules.
- 16.4 The decision-making process will consider the best interest of the game and fairness as top priorities and on occasion unusual circumstances may dictate that the technical interpretation of the rules be balanced against this process. In the event of a dispute relating to any Tournament, the Tournament Directors decision is final.

17 Privacy

Crown will handle Entrants' personal information in accordance with the Privacy Act 1988 (Cth) and Crown Perth's privacy policy, which is available at www.crownperth.com.au/general/policies/privacy-policy. Entrants' personal information obtained in relation to this Tournament is used for promotional material in accordance with clause 2.10 and for the purpose of identifying winners of this Tournament and notifying relevant third-party prize providers, and will not be disclosed to any other organisations, unless such disclosure is required by law.

18 Responsible Service of Alcohol

Crown Perth practises the responsible service of alcohol. Entry and continued participation in this promotion is subject to the Participating Venue's liquor serving policy and conditions of Crown Perth's applicable liquor licence.
