## **SCHEDULE**

Promoter:	Burswood Nominees Limited (ABN 24 078 250 307) as trustee for The Burswood Property Trust trading as Crown Perth, Great Eastern Highway Burswood, Western Australia 6100.
Entrants (who can enter?):	Australian Residents aged eighteen (18) years or over who are not excluded or prohibited from entering the Promoter's property or any Crown property for any reason.
	All Crown Rewards Members who are not excluded or prohibited from entering the Promoter's property or any Crown property for any reason.
	Entrants who have not been disqualified from any prior promotion, competition or offer for any reason by the Promoter.
	Entrants who are not a spouse, partner, sibling, parent or child of an Executive team member of the Promoter.
	Entrants who have provided or entered their personal information or contact details correctly.
	6. Entrants who are not provisional Crown Rewards Members or previous Crown Club members who have not updated their identification number to a Crown Rewards identification number.
Participating Venue(s)	Crown Perth
Promotion Period:	6am to 9:55pm Friday 18 July 2025 during the Promotional Period being a Promotional Day.  All times recorded throughout these Terms & Conditions are in Australian Western Standard Time.
Entry Mechanic:	To enter the Promotion, during the promotional period (6am to 9:55pm Friday 18 July 2025),
	Entrants will receive one (1) entry for every hundred (100) Crown Rewards Points earned at Crown Perth ( <b>Entry</b> ), up to a maximum of twenty (20) Entries per Day.
	Entrants must visit a Voucher Issuance Kiosk (VIK) on the Promotional Day to register all their accumulated entries into the virtual draws.
	To participate in the prize draws, entrants will need to register at a VIK from 5pm to 9.55pm.
	Registration is required to enter the draws. Entrants will need to visit a VIK to claim any additional entries earned in the same session after the initial

registration. Entrants who do not visit a VIK to register their participation during this period will not be considered an eligible entrant for the promotion.

For avoidance of doubt, if entrants register by 5.55pm, they will be eligible for all the 6pm, 8pm and 10pm prize draws.

There will be no entry forms printed. Entries are automatically added until the time of draw.

All entries earned on the promotional day are valid for all prize draws in both sessions, depending on the time an entrant register

In the event of any technical issues experienced during any Day, the Promoter reserves the right to alter the Entry mechanics, including but not limited to the process by which Entries are earned, which will be announced within the Promoter's venue during the relevant Promotional Day. Upon such technical issues being rectified the Entry mechanism detailed above shall resume. In the event of a technical malfunction, the Promoter reserves the right to pause or hold the Promotion until the malfunction is rectified and the Entry mechanism detailed above shall resume.

In the event of a severe technical malfunction, the Promoter reserves the right to pause or delay the Promotion into another time or another date which shall be announced within the Promoter's venue.

Crown Rewards points will be 'earned' at the time they are posted to the Eligible Entrant's Crown Rewards points balance in accordance with the Crown Rewards Terms and Conditions, see crownperth.com.au/crown-rewards. Crown Rewards points earned via Gaming activity must be earned via Active Play. Active Play means the entrant must have earned Crown Rewards points by actively gaming during the Promotional Period. Active Play does not include any points earned passively or without active gaming or betting.

### Prize Draw(s):

If a winner has not been identified at the time of the Prize Draw, an immediate redraw will occur. The redraw will be conducted as determined by the Promoter. The Promoter reserves the right to do a maximum of five (5) redraws. If no drawn Entrant has claimed the prize after five (5) redraws, the prize is forfeited.

In the event of any technical issues experienced during a Promotional Day, the Promoter reserves the right to alter the draw mechanics, which will be announced within the Promoter's venue on the relevant Promotional Day.

#### **Promotional Game**

Each of the five (5) drawn winners (Entrant) from the Prize Draws, will participate in a Promotional Game of 'Smash for Cash: Christmas in July'.

### 6pm and 8pm Draws

### **GENERAL TERMS & CONDITIONS**
