Promotional Game (11pm Jackpot Prize Winners)	<p>Once the three (3) 11pm Jackpot winners have been identified they will participate in a promotional game of 'Santa's Suprises' to determine their final prize.</p> <p>Prior to commencing the Promotional Game, each Jackpot Winner must present their Crown Rewards Membership Card and ID for verification. Should the Crown Rewards Membership Card and ID not match with the Jackpot winner identified, the prize will be deemed forfeited and the participant will be ineligible to play the Promotional Game.</p> <p>A Participant who is unable to participate due to health, medical or other reasons as approved by the Promoter, is permitted to nominate a proxy to participate on their behalf.</p> <p>The participants will each get to roll two dice to give them a value of 2-12. 	<ul style="list-style-type: none">• Third highest roll: \$1,000 cash plus third pick of the gifts <p>If jackpot winners are disqualified for failing to present their Crown Rewards membership card and valid ID, the remaining prizes will be awarded in order of the highest to lowest roll, following the sequence outlined above and any unused roll forfeited.</p>
Entry Mechanic:	<p>To enter the Promotion, during the entry period, entrants must:</p> <p>Play on any eligible gaming machine (excludes any Vegas Star, Lucky Big Wheel and Fusion terminals) across the Casino during each Promotional Day during the Promotion period.</p> <p>To qualify for a jackpot prize, a Crown Rewards Member must actively play on an Electronic Gaming Machine (EGM) using their own valid Crown Rewards Membership Card, which is registered in their name. Any Entrant found to be using another member's Crown Rewards Membership Card will be deemed ineligible. Prize Conditions	<p>a) Prize values are correct as at the date of preparing these Terms and Conditions. The Promoter is not responsible for any change in prize value.</p> <p>b) In the event of technical issues experienced during any Promotional Day, the Promoter reserves the right to pause, hold, delay or cancel the Jackpot until a time the technical issues are rectified, which will be announced within the Promoter's venue during the relevant Promotional Day.</p> <p>c) All warranty and workmanship issues relating to the Prizes are the responsibility of the respective supplier.</p>
How are winners notified?	<p>Winners will be notified that they have won a jackpot prize on the Gaming Machine screen if they are a Jackpot Winner. Winners can then claim the cash prizes to their account. The prizes will be added to the winner's gaming machine balance at the time of winning the jackpot. For the winners participating in the promotional game, the winning gaming machine will lockup and display a winner notification message. A gaming machine attendant will attend to the winner and guide the winner through the process of claiming the prize.</p> <p>In the event, they are unable to claim the prize, they should inform the promoter immediately, of which the promoter will issue them a manual payment slip.</p>

- e) **Indemnity:** Subject to their Consumer Rights, each Entrant and any person partaking in any component of the Prize, releases and indemnifies the Promoter from any claim, loss, damage, injury, expense, cost or charge sustained or in any way incurred in connection with the Prize or Promotion or participation in the Prize or Promotion.
